1. MATERIAL DESCRIPTION

The Seller agrees to sell, and the Customer agrees to purchase, bulk road salt according to the following terms:

- **Quantity Reserved:** _____ tons
- **Deposit Amount:** \$20.00 per ton
- **Total Deposit Paid:** \$ _____
- **Agreed Delivered Price:** \$ _____ per ton
- **Storage Period:** Through April 1, 2028

The agreed delivered price shall be established at the time this agreement is executed.

2. DEPOSIT TERMS

The Customer agrees to pay a non-refundable deposit of twenty dollars (\$20.00) per ton upon execution of this Agreement.

The deposit shall secure the Customer's reserved quantity of bulk road salt and shall be credited toward the final balance due upon delivery.

3. STORAGE OF MATERIAL

Champion Mulch and Landscape Supply agrees to store the reserved material through April 1, 2028, provided that the Customer remains in compliance with the terms of this Agreement.

4. DELIVERY AND FINAL PAYMENT

The remaining balance due shall be calculated as follows:

(Agreed delivered price per ton × quantity delivered)
– deposit previously paid

The remaining balance shall be due upon delivery unless otherwise agreed to in writing by both parties.

The minimum delivery quantity for each order shall be 20 tons.

5. ORDERING PROCEDURE

The Customer shall submit all delivery requests by email to **orders@gotochampion.com**.

Each request should include the following information:

- Customer name
- Delivery address
- Requested delivery date
- Quantity requested (in tons)
- Contact name
- Telephone number

Champion Mulch and Landscape Supply will confirm the quantity, delivery date, and delivery instructions upon receipt of the order.

Orders are subject to product availability, weather conditions, road conditions, and transportation scheduling.

6. EXPIRATION OF AGREEMENT

The Customer acknowledges that all material purchased under this Agreement must be ordered, delivered, and accepted on or before **April 1, 2028**.

Any material remaining after April 1, 2028, may, at the sole discretion of Champion Mulch and Landscape Supply, become the property of the Seller, and any deposit previously paid may be retained.
